



Total Cost of UT Title IX Lawsuit Reaches \$3M

According to [Campus Safety Magazine](#) eight people successfully sued UT-Knoxville for violating Title IX, saying the school inadequately responded to allegations of sexual misconduct by several athletes. As part of the agreement, the University admitted no guilt but will pay the settlement

plus attorney fees.

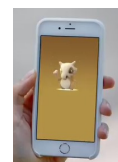
